

## **Experience**

Prudential Skyline Project – Newark, NJ: PS&S prepared detailed demolition contract documents for the existing buildings and site demolition as part of the major redevelopment project proposed over two adjacent city blocks approximately three acres each, including comprehensive Demolition Work Plan, Demolition Design Drawings and specifications, and provided supporting services for demolition permitting and bidding. PS&S also provided licensed site remediation professional (LSRP) services for the excavation of impacted soils and the removal of underground storage tanks (USTs).

Allied Signal – Morristown, NJ: PS&S provided detail design and specifications for demolition of two laboratory buildings of approximately 12,000 sf of footprint area, post-demolition site restoration, utility relocation, site remediation, soil erosion and sediment control (SESC) measures and permitting.
